
Digital Document Management

TRACEABILITY


REPORT FUNCTIONALITY

Plant and Equipment Management Module

The Plant and Equipment Management (PEM) Module of GPlus Live allows you to schedule, record and manage plant and equipment maintenance requirements.

The PEM Module also assists you generate work orders for upcoming service requirements and provide your preferred contractors with details and timing of when a job is required to be completed.

Having maintenance records in a central location makes recalling and reporting data simple.

REGISTERS AND EQUIPMENT PAGES

Fixed plant and mobile equipment registers provide an overview of machine status, including details such as make, model, current SMU and/or mileage.

Equipment pages allow you to investigate defects, complete pre-start checklists, schedule maintenance, link equipment (i.e., rims and trailers), track SMU history and mileage readings and store notes and documentation such as manuals and servicing history.

PRE-STARTS

Operators can complete equipment pre-starts on site using their hand-held devices simply by scanning a unique QR code fitted to the machine.

The system allows operators to attach images of potential defects or hazards, raise defect notes and select levels of severity. If desired, alerts can be automatically forwarded based on the selections made.



MILEAGE AND SMU HOURS


